This is to certify that the Commissioner – Highways has jurisdiction of the highways of the County of Erie and does hereby restrict that portion of the highway in the Town of Amherst, said County, known as Erie, and described as follows:

## **Restriction:**

That portion of Maple Road (CR 192) from Hopkins Road to Transit Road will have a daily single lane closure for a drainage system evaluation. This restriction will begin on December 13<sup>th</sup>, 2018 and will end on December 16<sup>th</sup>, 2018 or until complete. Clark Patterson Lee will be the contractor for this project.

A restriction is executed under Article V, Section 104A of the Highway Law in order to permit a proper completion of work of improvement thereon.
