


# Glen Park Photo Contest

In addition to the regular judging all photos will be posted on the park's Facebook page for judging to find the Facebook Fan Favorite. Winner of the Facebook Fan Favorite will win a special prize.

Winners will be notified by June 30th. An award ceremony will be held during the Glen Avenue Arts Festival on Saturday, July 30th. All photo contest participants and members of the public are welcome to attend the reception. The winning entries will be displayed online and throughout Town and Village sites.

Please note, the Glen Park Joint Board, the Village of Williamsville, and the Town of Amherst reserve the right to extend and/or postpone any of the deadline dates noted to ensure good participation and a successful fundraising effort.

### Contest Rules

- Inspired by last year's winner, photo entries should feature people in Glen Park and its immediate surroundings (i.e. the Mill) in 2010-2011. If the person is recognizable in the photo, a completed model release form must accompany the photo entry to be acceptable.
- The entry fee is \$10.00 for the first photo submitted and \$5.00 for each additional photo submitted by the same contestant. Make checks payable to "GPJB".
- A completed contest entry form/waiver (or a copy thereof) must be taped to the back of each photo entered.
- Each entry must consist of a single print that it is NO SMALLER than 5" x 7" and NO LARGER than 8" x 10". Please provide a digital copy of each image, as well, submitted on a disc.
