This notice is issued pursuant to Part 617 and Local Law #3-82, as amended, of the implementing

regulations pertaining to Article 8 (State Environmental Quality Review) of the Environmental Conservation Law.

The Lead Agency has determined that the proposed action described below will not have a significant adverse effect on the environment.

Description of Action:

Acceptance of a Local Waterfront Revitalization Program (LWRP) plan which address local and regional inland waterway issues within the Town of Amherst to improve water quality and natural areas, guide development to areas with adequate infrastructure and services away from sensitive resources, promote public waterfront access, and provide for redevelopment of underutilized waterfronts. The draft LWRP plan is comprised of the seven sections that are consistent with the requirements of the 2019 Guidance Manual for Preparing Local Programs developed by the New York State Department of State (NYSDOS) and includes the proposed waterfront revitalization boundary, inventory and analysis of the boundary, policies, recommended waterfront projects and compliance with local, state and federal laws. Proposed actions within the waterfront revitalization boundary will need to adhere to a "Consistency Review".

REASONS SUPPORTING THIS DETERMINATION

Based on information submitted by the applicant including a Full Environmental Assessment Form (EAF) - Part I, (as amended) and Part II and a complete site plan application, a preliminary staff analysis was undertaken. Compared to the criteria listed in Section 617.7, all indications are that this action will not have a significant impact on the environment, as follows:

- 1. The project is not expected to cause a substantial adverse change in existing air quality, ground or surface water quality or quantity, or noise levels; a substantial increase in solid waste production; or a substantial increase in the potential for erosion, flooding, leaching or drainage problems.
- 2. The project will not result in the removal or destruction of large quantities of vegetation or fauna; or in significant adverse impacts to fish or wildlife species, habitats or other natural resources.
- The project is not expected to create any material conflict with the Town Comprehensive Plan. This project is consistent with the following Sections of the Comprehensive Plan; Section 3.0 Land Use and Development, Section 4.0 Natural and Cultural Resources, Section 6.0 and Section 7.0 Infrastructure. The project is consistent with the following policies of the Town of Amherst Comprehensive Plan; 3-13, 3-15, 4-1, 4-2, 4-3, 4-4, 4-5, 4-6, 4-7, 4-8, 4-9, 4-10, 4-11, 4-13, 4-14, 6-7, and 7-1.
- 4. The project is within an area identified by the State as having potential archaeological or historical significance. The action will not impair the character or quality of important cultural resources.
- 5. The project will not impair the character or quality of important aesthetic resources or of existing community or neighborhood character. The policies and goals of the Town of Amherst Local Waterfront Revitalization Program plan will preserve and enhance the character of the Town.
- 6. The project will not cause a major change in the use of either the quantity or type of energy.
- 7. The project will not create any hazard to human health.
- 8. The project will not cause a substantial change in the use, or intensity of use, of land including agricultural, open space or recreational resources, or in its capacity to support existing uses. The future land use figure in Section 4 of the Town of Amherst Local Waterfront Revitalization Program plan will be consistent with the Town of Amherst Comprehensive Plan.




