Notice is hereby given that the Assessor of the Town of Amherst, County of Erie, State of New York has completed the 2021 Tentative Assessment Roll pursuant to Section 506 & 512 of the Real Property Tax Law.(Section 3-3.0 Erie County Tax Act, As Amended).

The Assessment Roll for 2021 will be able to be viewed electronically at the Town of Amherst website at [www.amherst.ny.us](http://www.amherst.ny.us) on the home page. It can also be viewed at the Assessors page on same web site.

A copy thereof will also be open for public inspection in the Assessor's Office at Amherst Town Hall, 5583 Main Street Williamsville, New York, from May 4<sup>th</sup> 2021 to May 25<sup>th</sup>, 2021 between the hours of 8:30 a.m. and 4:30 p.m., Monday through Friday where it may be seen and examined by any person interested therein. To view it in-person you must wear or bring your own form of Personal Protective Equipment to enter Town Hall and maintain appropriate Social Distancing. Additional hours will also be available on Thursday May 13<sup>th</sup> 2021 from 6-8 pm and Saturday May 15<sup>th</sup> 2021 from 8 am-Noon (Both days by appointment only).

The Board of Assessment Review will meet on Tuesday May 25<sup>th</sup>, 2021 between the hours of 9:00 a.m. and 4:30 pm and 6:00 p.m. and 8:00 p.m. at Amherst Town Hall, 5583 Main Street, Williamsville, New York to hear and examine, all verified written complaints in relation to assessments of any person believing himself to be aggrieved. Appointments are recommended, and you can call the Assessor's office after May 5<sup>th</sup> at 716-631-7038 to schedule an appointment. Reviews can also be done on a non-hearing basis by dropping off or mailing in your information to the Assessor's office. *Please be aware that based on recent Judicial Decisions, the Board of Assessment Review WILL NOT accept any filings sent by electronic means (e-mail, etc.) Please consider any sent electronically as not received by the Town of Amherst*

Applications, including the mandatory RP 524 form, and publications outlining procedure for contesting assessments are available on the Town of Amherst Website at [www.amherst.ny.us](http://www.amherst.ny.us) on the Assessor's page or available at the Assessor's Office at Town Hall, 5583 Main Street Williamsville, NY 14221.

Forms will be available starting May 4<sup>th</sup> 2021.The last day to file complaints with the required RP 524 form is **Tuesday, May 25<sup>th</sup>**, 2021 at 8:00 PM.
