

REQUIRED INSPECTIONS - COMMERCIAL

The following inspections are the minimum applicable to most commercial projects. Many commercial projects will require additional inspections or multiple site visits for a single inspection item. Since commercial construction varies widely in its scope it is important for the contractor to contact the appropriate inspector before the work commences and to discuss specific inspection requirements.

NO WORK MAY BE CONCEALED UNTIL INSPECTED FAILURE TO REQUEST INSPECTIONS WILL RESULT IN A **STOP WORK ORDER** NOTIFY INSPECTOR AT LEAST 24 HOURS IN ADVANCE

NO WORK ABOVE THE FOUNDATION UNTIL A FOUNDATION SURVEY IS SUBMITTED AND APPROVED BY THE BUILDING DEPARTMENT

ROUGH

Masonry Walls (Fire walls require fire rated units) Fill cores of units below grade Wall reinforcing (bond beams, vertical bars, etc.) Steel Erection Roof Deck Certification of structural systems by a registered professional required, Steel Stud (or wood) Framing Exterior Interior Walls required to be smoke tight must be inspected prior to installation of ceilings. All Electrical and Plumbing work must be installed. Inspected by the applicable inspector prior to calling for the building inspector's permission to conceal any portion of the work. MECHANICAL SYSTEMS Plumbing -Coordinate with Plumbing Inspector Electrical -Coordinate with Electrical Inspector

HVAC -Coordinate with Building Inspector

Fire Protection Systems. Coordinate \\ith Building and Fire Inspectors

Cooking Hoods & related equipment - Coordinate with Building and Fire Inspectors.

Building, Plumbing, Electrical and Fire Inspectors plus

Highway Department (Town, County or State) and

Other departments when an approved site plan is involved.
