Supplemental Information Memorandum for the Full Environmental Assessment Form

Purpose

This memorandum is submitted as supplemental information pursuant to Part 1, Section F of the Full Environmental Assessment Form (FEAF) for the proposed construction of four 5 MW AC, four-hour-duration battery energy storage systems on an approximately 3.9-acre parcel located at 370 Youngs Road in the Town of Amherst. The information below supports and clarifies the FEAF responses concerning federal agency review, coastal resources, wetlands and surface waters, threatened and endangered species, rare species and significant natural communities, and historic and archaeological resources.

Threatened, Endangered, and Rare Species

FEAF Sections E.2.n, E.2.o, and E.2.p

The New York Natural Heritage Program reviewed its database for the Renaissance BESS Project and, by letter dated December 19, 2025, reported no records of rare or state-listed animals or plants or significant natural communities at the Project site or in its immediate vicinity. The letter notes that the absence of records does not constitute a definitive determination that such resources are absent because comprehensive field surveys have not necessarily been completed. The Natural Heritage Program correspondence is included as Attachment 5.

The U.S. Fish and Wildlife Service Information for Planning and Consultation (IPaC) resource list identifies the federally endangered northern long-eared bat, the proposed endangered salamander mussel, and the proposed threatened monarch butterfly as species that may potentially be affected by activities within the broader Project area. IPaC is a screening-level resource and does not establish that the identified species are present on the Project site. IPaC indicates that no critical habitat has been designated for the northern long-eared bat, that the Project location does not overlap the proposed critical habitat for the salamander mussel or monarch butterfly, and that no designated or proposed critical habitat occurs at the Project location. The IPaC resource list is included as Attachment 4.

No tree clearing is proposed as part of the Project. Accordingly, impacts to the northern long-eared bat associated with the removal of potential roosting habitat are not anticipated. The Project site is not located within or adjacent to freshwater habitat suitable for the salamander mussel. Therefore, impacts to the salamander mussel are not anticipated.

The proposed facility would be located within a field that is regularly mowed and maintained. As a result, the Project is not anticipated to adversely affect monarch butterfly habitat.

Based on the available federal and state screening information and the proposed scope of disturbance, no listed or rare species, significant natural communities, or designated or proposed critical habitat are known to occur on the Project site. This information supports the responses provided in Sections E.2.n, E.2.o, and E.2.p of the FEAF.

Wetlands and Surface Waters

FEAF Sections D.2.b and E.2.h

A field wetland delineation of the Project parcel was completed on June 24, 2026. The resulting wetland delineation map is included with the application materials.

The New York State Department of Environmental Conservation (NYSDEC) issued a Letter of No Jurisdiction dated January 29, 2026. NYSDEC determined that there are no state-regulated freshwater wetlands or regulated adjacent areas on the Project parcel and that no freshwater wetlands permit is required under Article 24 of the Environmental Conservation Law or 6 NYCRR Part 663. The determination remains valid through January 27, 2031. The Letter of No Jurisdiction is included as Attachment 3.

The IPaC National Wetlands Inventory screening also indicates that the Project location does not intersect any federally mapped wetlands. IPaC notes that this screening does not replace an on-site wetland delineation.

Based on the completed field delineation and available agency information, the proposed Project will not alter, encroach upon, or otherwise disturb wetlands, waterbodies, shorelines, or adjacent regulated areas. No NYSDEC freshwater wetlands permit is required. Because no impacts to wetlands or other waters of the United States are proposed, authorization from the U.S. Army Corps of Engineers is not anticipated. This information supports the responses provided in Sections D.2.b, E.2.h.i, E.2.h.ii, and E.2.h.iii of the FEAF.

Local Waterfront Revitalization Program

FEAF Section B.i

The Applicant coordinated with the Town of Amherst Planning Department regarding the applicability of the Local Waterfront Revitalization Program (LWRP). By correspondence dated June 2, 2026, the Planning Department confirmed that the Project parcel at 370 Youngs Road is not located within the Town of Amherst/Village Waterfront Revitalization Area established under the New York State Department of State LWRP. The FEAF Mapper likewise identifies the Project site as outside both a coastal or waterfront area and a Local Waterfront Revitalization Area.

Accordingly, the Project is not subject to an LWRP consistency review, a Waterfront Assessment Form is not required, and no further LWRP-related action is necessary. This information supports the responses provided in Sections B.i.i and B.i.ii of the FEAF.

Historic and Archaeological Resources

FEAF Sections E.3.e, E.3.f, and E.3.g

The New York State Office of Parks, Recreation and Historic Preservation (OPRHP), acting as the State Historic Preservation Office, reviewed the Renaissance BESS Project in accordance with Section 14.09 of the New York State Parks, Recreation and Historic Preservation Law.

By letter dated November 7, 2025, OPRHP determined that no properties, including archaeological or historic resources listed in or eligible for listing in the New York State or National Registers of Historic Places, will be impacted by the Project. The OPRHP Project Review number is 25PR10482. The determination letter is included as Attachment 2.

Although the FEAF Mapper identifies the Project site as being within or adjacent to an area mapped as sensitive for archaeological resources, the subsequent site-specific OPRHP review determined that the Project will not impact listed or eligible archaeological or historic resources. The OPRHP determination supports the responses provided in Sections E.3.e and E.3.g and clarifies the response provided in Section E.3.f of the FEAF.

Federal Aviation Administration Coordination

FEAF Section B.h

Notice to the Federal Aviation Administration (FAA) is required for the proposed Project. The required Notice of Proposed Construction or Alteration (FAA Form 7460-1) was filed on July 27, 2026, and the FAA aeronautical study is currently in process. Although the final FAA determination is pending, the Project does not propose any structures that would exceed the height of existing structures adjacent to the proposed facility. Accordingly, the Project is not anticipated to trigger additional FAA review. The final FAA determination will be provided to the Town upon issuance.

Conclusion

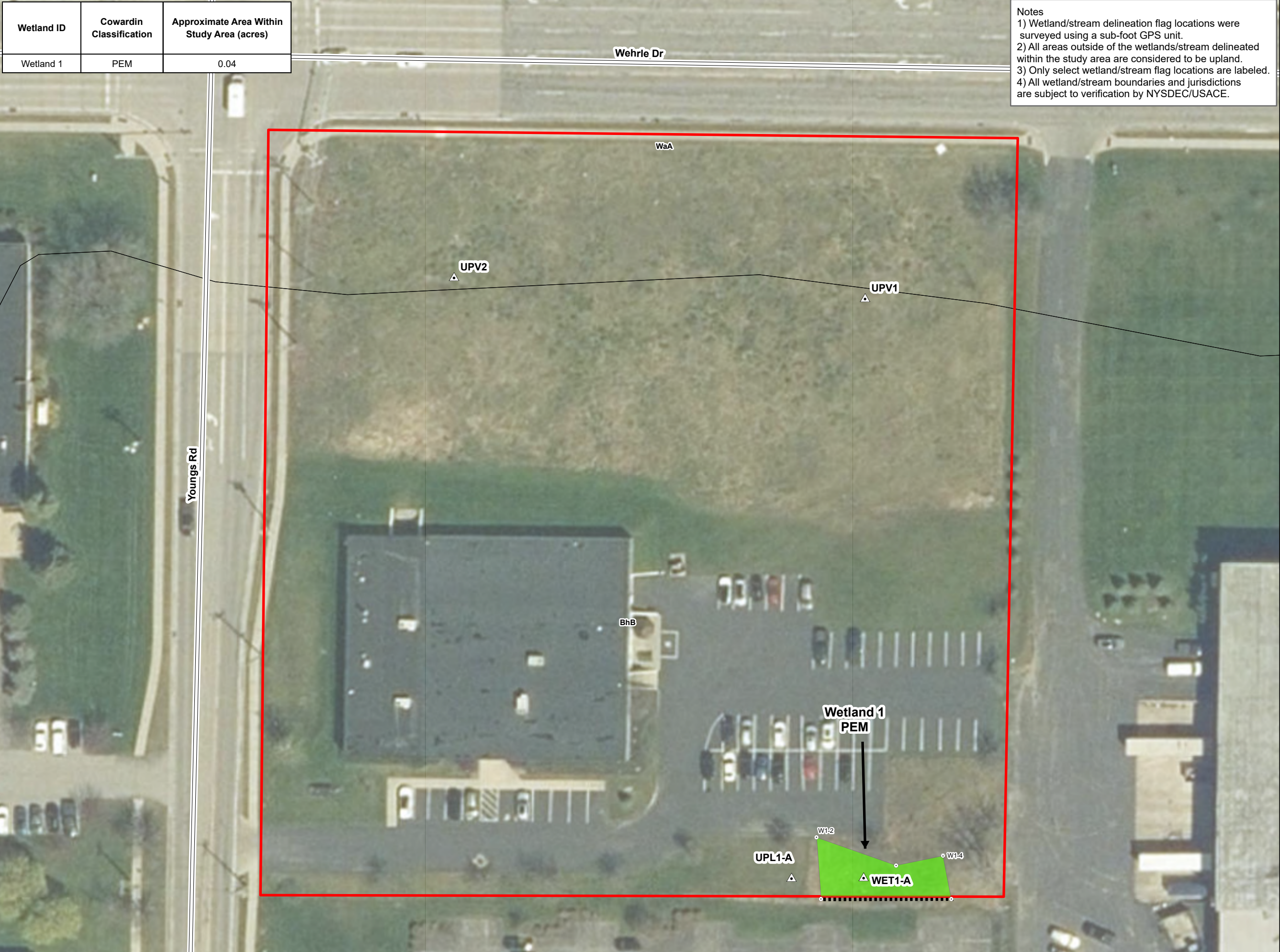

Based on the parcel(s) identified in your request, the New York State Department of Environmental Conservation (DEC) has determined that there are no DEC regulated freshwater wetlands and/or adjacent areas identified on the parcel(s) referenced above. Therefore, in accordance with Article 24 of the Environmental Conservation Law (ECL) and 6 NYCRR Part 663, no freshwater wetlands permit is required. Pursuant to ECL section 24-0703, this letter shall remain valid for a period of five years from the date it is issued (through 01/27/2031).

Please note that this determination pertains only to state-regulated, freshwater wetlands and regulated adjacent areas. DEC also regulates protected streams, tidal wetlands, coastal erosion hazard areas, and other important environmental resources. Work affecting those areas may also require DEC permits. 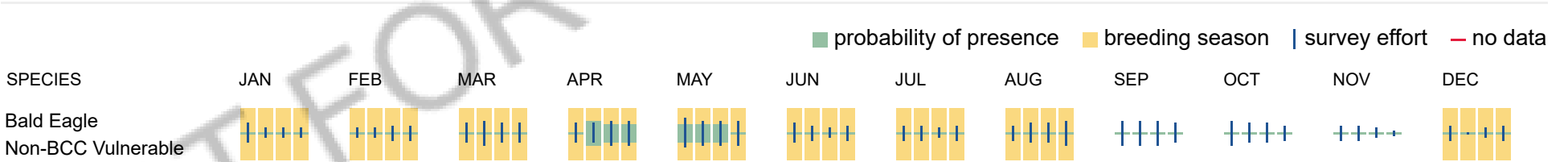

Bald & Golden Eagles FAQs

What does IPaC use to generate the potential presence of bald and golden eagles in my specified location?

The potential for eagle presence is derived from data provided by the [Avian Knowledge Network \(AKN\)](#). The AKN data is based on a growing collection of [survey, banding, and citizen science datasets](#) and is queried and filtered to return a list of those birds reported as occurring in the 10km grid cell(s) which your project intersects, and that have been identified as warranting special attention because they are an eagle ([Bald and Golden Eagle Protection Act](#) requirements may apply).

Proper interpretation and use of your eagle report

On the graphs provided, please look carefully at the survey effort (indicated by the black vertical line) and for the existence of the "no data" indicator (a red horizontal line). A high survey effort is the key component. If the survey effort is high, then the probability of presence score can be viewed as more dependable. In contrast, a low survey effort line or no data line (red horizontal) means a lack of data and, therefore, a lack of certainty about presence of the species.
