- 1. As the ground-level parking lot and basement ramp entrances have been switched, the applicant is required to provide a supplemental traffic analysis reflecting this change. The revised analysis must include updated trip distribution diagrams replacing Figures 6, 6A, 7, and 8 of the Passero traffic assessment dated January 18, 2023.
- 2. Install signage to prohibit left turns from the proposed Chateau Terrace ground-level parking lot.
- 3. Install signage to prohibit right turns from the proposed Fruehauf Avenue basement-level parking garage.
- 4. Improve visibility or detection for outbound drivers at the Fruehauf Avenue ramp driveway to ensure pedestrian safety. This may be achieved through the use of technology or an appropriate engineering solution.
- 5. To minimize the potential for pedestrian-vehicle conflicts on the public sidewalk along Fruehauf Avenue, remove the proposed sidewalk north of the driveway curb cut on the east side of Fruehauf Avenue. Apply for a sidewalk waiver through the Town for this section of sidewalk.
