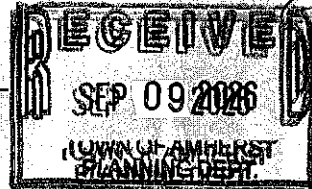

The proposed project consists of a four-story multifamily building comprised of 48 attached residential units, four unit townhome buildings, and includes the proposed public roadway extension of Joe McCarthy Drive between Edward Chaffee Drive and Edward White Drive. The Project Site consists of twelve vacant parcels located on the east side of Joe McCarthy Drive. The proposed action has been defined broadly to include all required discretionary approvals and permits from the Town's municipal boards as well as all proposed site improvements including but not limited to the multifamily building, access aisles and parking spaces, lighting, landscaping, stormwater management, utility improvements and connections.

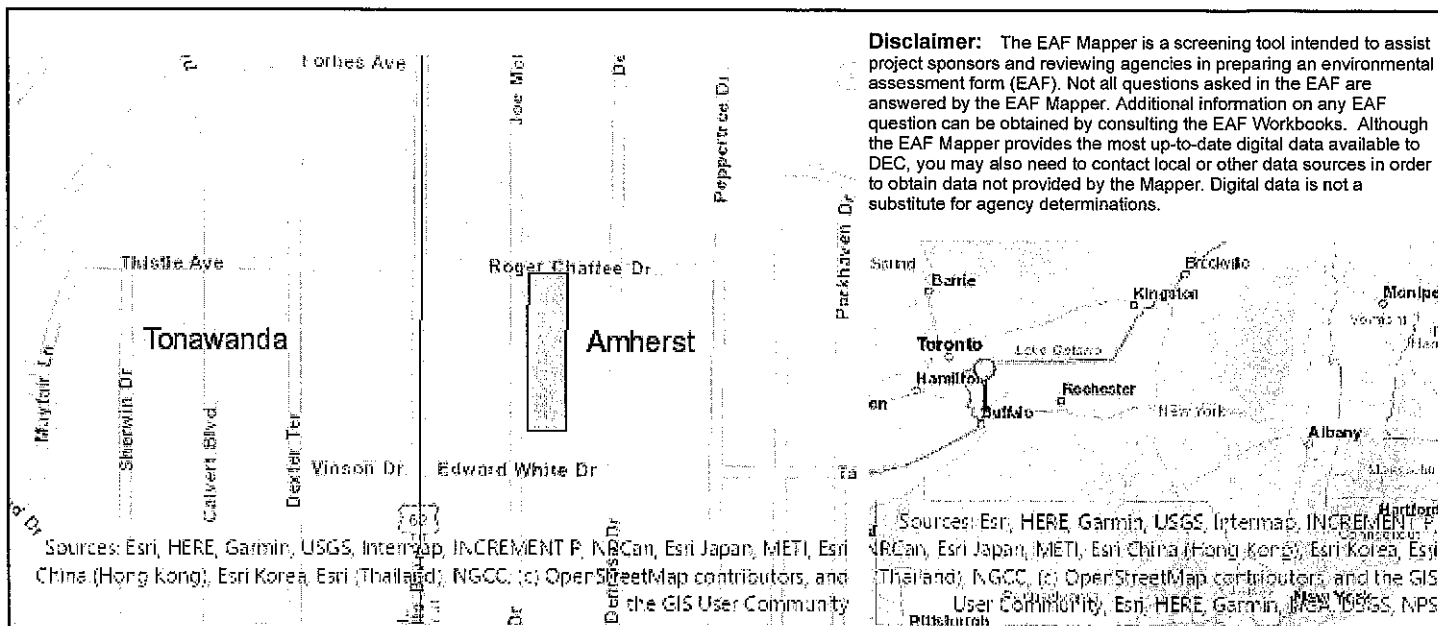
