**Large Culvert (C530140) Replacement on I-990 and Signal
Rehabilitation on I-990 Off-Ramp at NY 263 (Millersport
Hwy), Town of Amherst, Erie County**

The New York State Department of Transportation (NYSDOT) will discuss a proposed large culvert replacement project at the November 2025 Amherst Town Board Meeting. The meeting will primarily focus on the culvert located on Interstate 990 over the tributary to Ransom Creek. It will also address traffic signal rehabilitation at the intersection of the Interstate 990 off-ramp and Millersport Highway in the Town of Amherst, Erie County

Project Description:

The New York State Department of Transportation (NYSDOT) is proposing to replace the existing double-barrel metal culvert (C530140) with a 14'x7' reinforced concrete box spanning beneath the on-ramp and off-ramp of Interstate 990. The traffic signal at the intersection of the Interstate 990 off-ramp and Millersport Highway will be rehabilitated with updated features.
